

(a) Complainant, Nicolette Worobetz, and Respondent, PPL Electric, agree that Complainant will make a payment of \$200.00 to Respondent no later than September 14, 2014. Complainant and Respondent further agree that Complainant will subsequently pay her regular monthly bill plus \$15.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent further agree that Complainant is eligible for re-certification with the OnTrack customer assistance program on September 6, 2014. Complainant and


Respondent further agree that Respondent sent a referral for Complainant to receive an application from her local agency, and that Respondent referred Complainant to the WRAP customer assistance program through PPL EU.

(b) Complainant agrees to withdraw her Complaint.
