Please accept this correspondence acknowledging receipt of the complaint set forth by the Pennsylvania Public Utility Commission Bureau of Investigation and Enforcement against Premier Luxury Rentals (Docket No. C-2014-2432573). We are not contesting the complaint and have enclosed a check in the amount of \$2,555.00.

We understand we have also been assessed a civil penalty in the amount of \$383.00 for the delay in our payment (15% of the assessment owed to the PUC), along with a \$1,000.00 fine for not reporting our gross intrastate operating revenues in 2012. We are not contesting these fines, but rather respectfully request they be waived due to our enclosed mailed correspondence to David W. Loucks, Chief Motor Carrier Enforcement Bureau of Investigations and Enforcement, on January 30, 2014 requesting an extension to pay our assessment.

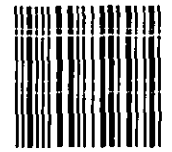
Dear Mr. Loucks,

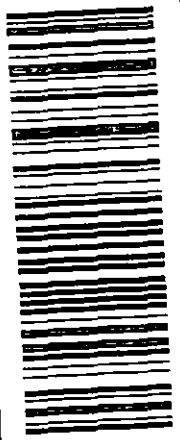
