



On May 30 and August 31, 1995, the Commission sent billings to your company for your assessment for our 1995-96 fiscal year. You have made no payment on the total assessment of \$54.00.

You are directed to pay the outstanding amount of your assessment by January 5, 1996. Your check or money order, payable to the Commonwealth of Pennsylvania, should be forwarded to Carmon Bass, Pennsylvania Public Utility Commission, P.O. Box 3265, Harrisburg, PA 17105-3265. Failure to make timely payment will result in the institution of an action to cancel your certificate of public convenience.

In the event that your certificate is cancelled, additional action will follow. Pursuant to 66 Pa. 



This letter is in reply to the letter that was sent to me on the thirteenth of January 2005. About the notice of suspension. I am requesting from the commission some way to hold my license in escrow or safe keeping until I can afford the insurance on the vehicles some time in the spring of this year. I have always been given at least six to eight quotes from my insurance company for insurance coverage for me to choose. Since 1989 I have had the same insurance company and my representative was Rich Klavon he searched for me the best possible rates and made sure I received the best service. Unfortunately he took another job in August of last year. With my insurance being due, I had no choice but to still try to go with the same company. That was a big mistake. Because the gentleman they assigned to my account knows nothing about how to get quotes or otherwise. In other words he is just plain clueless when it comes to this field. My insurance premium was quoted \$3,500.00 more than last year and \$1,200.00 a month higher. With the weather and this extremely slow season this is not feasible for me. So I need some time to look for another insurance carrier. I have not had any accidents or claims on my record of any kind so there have got to be company's out there cheaper. But this company after all the years of business I have given them, does not care to find me better rates. Please I do not want to loose this license that I have had since 1989. I just am in need of more time to hold it till spring or sooner to get a decent quote from a decent company. One that is not trying to screw me just because they knew this would happen if I did not pay their costs. I feel that is entrapment to say the least. They never told me until the day before my insurance was due how much it was going to cost knowing full well it was a very large increase and I would have no choice but to pay it. That by all means is not fair. The very minute I get a better quote I will assume the insurance and fax you the form E and send a hard copy through the mail. But whatever you do don't let me loose this authority I will do what ever it takes to keep it. I am in hopes that the commission can do as I asked and put a hold on the license. Just however it is done. It would truly be appreciated as I have been a good and honest carrier and want to continue to be one in the future. Thank-you for your time in this matter.
