SUPPLEMENTAL ORDER CANCELLING
CERTIFICATE OF PUBLIC CONVENIENCE

BY THE COMMISSION:

It appearing that all the rights granted to Stillwell of Media, PA, Inc. (Stillwell), under the certificate of public convenience issued at A-00090678, F. 2 and F. 3 were transferred to F. Ambrose Moving, Inc. (Ambrose), at A-00108228 by order adopted September 29, 1988 and entered October 6, 1988.

A petition for reconsideration was filed on October 17, 1988, requesting a correction to the order entered October 6, 1988. The petition was granted by order adopted November 23, 1988, and entered on December 2, 1988.

Although the rights transferred to Ambrose were held by Stillwell at Folders 2 and 3, neither of the orders issued by the Commission contained any reference to the cancellation of Stillwell's rights in the Supplemental Order. The name was also inadvertently spelled as Stillwater rather than Stillwell, THEREFORE;

IT IS ORDERED: That upon compliance with the conditions and requirements as set forth in the order at A-00108228, all the operating rights and the certificate of public convenience at A-00090678, Folder 2 and Folder 3 be and are hereby cancelled, and all rights, powers and privileges granted thereby shall forthwith cease and terminate.

IT IS FURTHER ORDERED: That a copy of this supplemental order at A-00090678, F. 2 and F. 3, be forwarded to Mr. George R. Otto, Regional Audit Supervisor, Department of Revenue, 10th Floor, Strawberry Square, Harrisburg, Pennsylvania.
