

This communication is being sent to your attention in compliance with the formal notification requirements associated with a material change to business operations as set forth by the Pennsylvania Public Utility Commission. On June 30, 2014 all ownership interest in Ecova was acquired by Cofely USA, Inc., an indirect subsidiary of GDF Suez Energy Services, SA. GDF SUEZ Energy Services represents one of the five business lines within the GDF SUEZ Group. We note that a separate business line within the GDF SUEZ Group includes a member that independently owns and operates generation facilities located in the State of Pennsylvania.

Ecova, Inc. expects to maintain its senior leadership, its brand and its current business plan. Ecova, Inc. is currently licensed as an Electric Broker/Marketer under Docket #A-2011-2234410 and Natural Gas Broker/Marketer under Docket #A-2013-2394195.
