In response to the letter dated June 25, 2014, Champion Energy Services is submitting timely response to the request for proof that a license bond or other approved security has been obtained. Specifically, there is a question as to the expiration date of Champion's existing security instrument. In support of Champion Energy Services' position that approved security has been maintained please find the following.

Champion Energy Services submitted an original letter of credit to the Commission on July 14, 2011 which included language that the letter of credit will be automatically extended. The renewal language in the original letter of credit reads:

IT IS A CONDITION OF THIS LETTER OF CREDIT THAT IT WILL BE AUTOMATICALLY EXTENDED FOR PERIODS OF ONE YEAR EACH FROM THE PRESENT OR ANY FUTURE EXPIRY DATE, UNLESS WE NOTIFY YOU IN WRITING AT LEAST 90 DAYS PRIOR TO SUCH EXPIRY DATE THAT WE ELECT NOT TO FURTHER EXTEND THIS LETTER OF CREDIT UPON RECEIPT OF SUCH NOTICE, YOU MAY DRAW ON THIS LETTER OF CREDIT, UP TO THE UNUSED BALANCE, BY PRESENTATION OF YOUR SIGHT DRAFT DRAWN ON WELLS FARGO BANK, N.A., ONE FRONT STREET, 21ST FLOOR, MAC A0195 - 212, SAN FRANCISCO, CA. 94111, ATTENTION: US TRADE SERVICES - STANDBY LETTERS OF CREDIT, ON OR BEFORE THE THEN RELEVANT EXPIRY DATE.

Enclosed, please find a copy of the original letter of credit, with highlighted section as noted above, and all amendments as proof that Champion Energy Services, LLC has maintained the appropriate security to ensure the financial responsibility as an electric generation supplier.




