**CERTIFICATE OF SATISFACTION**

1. Complainant is Luz Rivera.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as “PPL Electric”).
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter “Commission”), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
  - (a) Complainant, Luz Rivera, and Respondent, PPL Electric, agree that in December of 2013, Respondent transferred \$3,705.84 from account number 91260-99080, service address 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA, to Complainant’s account number 91260-99099, as a result of a foreign wiring investigation. Complainant and Respondent further agree that Respondent will credit Complainant’s account number 91260-99099 in the amount of \$1,852.92, which represents fifty percent (50%) of the total amount of the aforementioned

balance transfer. Complainant and Respondent further agree that Complainant has represented that all foreign wiring issues have been corrected at the property located at 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA as of January 1, 2014. Complainant and Respondent further agree that Complainant has represented that a new tenant (the "current tenant") moved into the property located at 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA in January of 2014, after all foreign wiring issues were corrected. Complainant and Respondent anticipate that the current tenant will immediately execute and submit a fix form to Respondent, which will allow Respondent to establish the electric service at 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA in the name of the current tenant, and simultaneously remove electric service at 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA from Complainant's name. Complainant and Respondent further anticipate that the current tenant will confirm that he has been residing at 114 N. 4<sup>th</sup> Street, 1<sup>st</sup> Floor, Columbia, PA since January 2014, after all foreign wiring issues were corrected. Provided that the current tenant submits the fix form to Respondent with the aforementioned notations, Respondent will also transfer all charges incurred on account number 91260-99099 since January 2014 into the name of the current tenant, which will simultaneously provide Complainant with an additional credit on her account. After this transfer occurs, Complainant and Respondent agree that Respondent will contact Complainant for the purpose of informing her of the total balance remaining on account number 91260-99099. Complainant and Respondent further agree that Complainant will pay back the remaining balance on her account number 91260-99099 in equal monthly installments over the course of sixty (60) months.

(b) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the

Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
