1. Complainant is Bernie Cieloszyk.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as “PPL Electric”).
3. This Amended Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter “Commission”), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, Bernie Cieloszyk, and Respondent, PPL Electric, agree that Complainant’s service has been terminated for nonpayment. Complainant and Respondent further agree that Complainant will pay Respondent no less than \$3,000.00 to reconnect service, and that Complainant will subsequently pay his regular monthly bill plus \$200.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent further

agree that Respondent will reconnect Complainant's electric service within one business day of payment of the reconnection fee is received by Respondent.

(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Amended Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Amended Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Amended Certificate of Satisfaction was signed and served, or the terms of the Amended Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
