Dear Complaints Representative,

I am contacting you regarding the Formal Complaint that we have filed against Blue Pilot Energy (#2014-2432979). After receiving our PECO bill with excessive charges from Blue Pilot (24.9 cents per kWh), we paid PECO the fair rate of 7.9 cents per kWh. We also have notified PECO of this matter and have instructed and contracted them to not remit any more than 7.9 cents per kWh to Blue Pilot for this account.

We have contacted PECO to discuss these billing matters; however, they have not received any confirmation of the PUC Complaint that we have filed against Blue Pilot, so they are only able to put a 30-day hold on the account. I ask that confirmation of our Formal Complaint be sent to PECO by the PUC as soon as possible in order to address this situation.

It is our understanding that there are many Formal Complaints filed against Blue Pilot for instances identical to ours and it is imperative that the PUC represent the interests of the citizens of commonwealth.

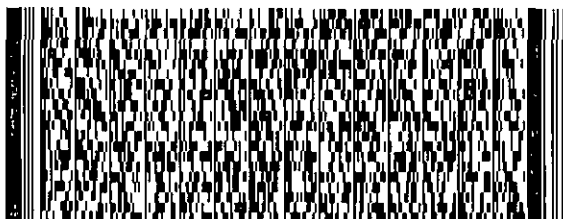
