MOTION FOR CONTINUANCE OF HEARING DATE

PECO Energy Company ("PECO Energy"), pursuant to 52 Pa. Code § 1.15(b), hereby requests a continuance of the hearing date scheduled in this matter and states the following:

1. An initial in-person further hearing for this matter is currently scheduled to take place today, Wednesday, August 26, 2014, at 10:00 a.m.
2. PECO Energy requests a continuance of this matter.
3. This matter arises from a termination that took place at the Complainant's delicatessen due to PECO's inability to gain access to maintain a meter that was sending sporadic signals.
4. PECO Energy intends to produce the testimony of Analyst, Dan Heine who will testify on the Data Raker data retrieved from the customer's meter.
5. Mr. Heine is on vacation and he is not available on the hearing date.
6. Accordingly, PECO Energy respectfully requests a continuance of this matter and a hearing date any time after September 2, 2014.
7. PECO Energy reached out to the Complainant's counsel, Craig Sopin, Esquire to advise him and he has no objection to the company's continuance request.
8. The Prehearing Order in this matter states that requests for a continuance are only granted "in rare situations where good cause exists." (Prehearing Order, citing 52 Pa. Code § 1.15).

9. PECO Energy avers that “good cause” exists to continue the scheduled hearing to another date because one of PECO Energy’s critical witnesses is unavailable.

10. PECO Energy therefore respectfully requests that the hearing be continued to a further date.
