Dear Secretary Chiavetta,

As chairman of the House Committee on Agriculture and Rural Affairs, I received a copy of the August 21, 2014, correspondence to you that included comments for the record by Representatives Fee, Hickernell, Denlinger, Cutler, Aument, Mentzer, and Greiner.

Having devoted considerable research and thought to this topic in recent months, I entirely agree with the views expressed by those representatives.

The 110% standard would accomplish simultaneous injury to Pennsylvania agriculture and AEPS goals. As I am certain that most members of the PUC will readily understand, much of agriculture is inherently seasonal with correspondingly varying energy demands during the course of each year that also can be affected radically by weather from one year to the next. The proposal before the PUC would certainly discourage agricultural investment in AEPS projects as agriculture cannot economically afford the risk that a future years weather pattern can determine whether they are selling to the grid. The PUC should not adopt this proposal that would discourage agricultural investments in AEPS projects.

Furthermore, the Commonwealth's commitment to improving the Chesapeake Bay can only be accomplished with technologies such as anaerobic digesters. The PUC should not adopt a policy that discourages deployment of this expensive technology. If it were to do so, the PUC would contradict the state's efforts for clean water and undermine compliance with onerous federal mandates.
