Dear Secretary Chiavetta:

On August 28, 2014, PECO Energy Company ("PECO" or "Company") filed with the Pennsylvania Public Utility Commission ("PUC" or "Commission") a document entitled "Joint Petition for Partial Settlement" ("Petition") in the above-captioned proceeding. As set forth below, the Philadelphia Area Industrial Energy Users Group ("PAIEUG"), while a party to the above-captioned proceeding, is not a signatory to the Petition. Rather, PAIEUG is submitting this letter to clarify and confirm its opposition to the Petition.

In Footnote 1 of the Petition, PECO indicates that PAIEUG "has not joined this Joint Petition or indicated that it does not oppose the Settlement." Petition, p. 1, note 1. This language fails to accurately convey PAIEUG's position with respect to the Petition.¹ By way of clarification, PAIEUG opposes the Petition, and PAIEUG repeatedly confirmed its opposition to the Petition to PECO prior to the Company's filing. Pursuant to the modified briefing schedule approved by Administrative Law Judge Cynthia Fordham on August 18, 2014, PAIEUG will file a Reply Brief on September 4, 2014, which shall more fully address its reasons for opposing the Petition.
