(a) Complainant, Leah Albertson, and Respondent, PPL Electric, agree that Complainant will make a payment of \$102.00 to Respondent no later than September 8, 2014. Complainant and Respondent further agree that Complainant will subsequently pay her regular monthly budget bill plus \$51.00 toward arrearages, until all arrearages are paid in full, beginning with Complainant's October 2014 due date. Complainant and Respondent further

agree that Complainant's monthly budget bill amount is \$175.00 for the next three months, and will subsequently adjust based upon Complainant's quarterly electric usage.

(b) Complainant agrees to withdraw her Complaint.
