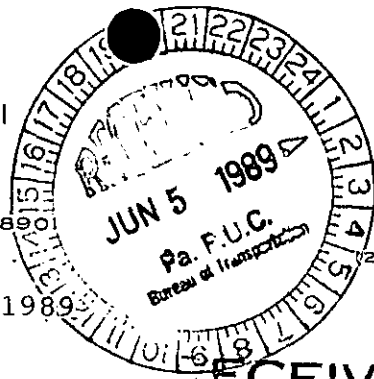

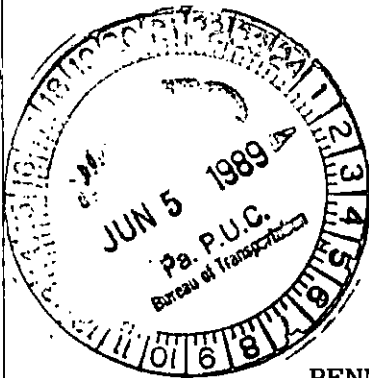

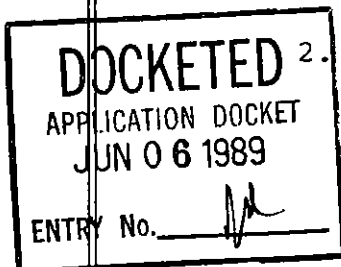

WITH RIGHT NO. 4 ABOVE, SUBJECT TO THE FOLLOWING CONDITION:

- (a) That no right, power or privilege is granted to transport commodities in bulk in tank vehicles or in hopper-type vehicles.
