

CERTIFICATE OF SATISFACTION

1. Complainants are Ghassan and Erlinda Youwakim.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding as to Respondent, PPL Electric, only, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainants, Ghassan and Erlinda Youwakim, and Respondent, PPL Electric, agree that Respondent will apply a credit in the amount of \$923.33 to Complainant's account, No. 40610-14108. This will leave a remaining balance of \$1134.78. Complainant agrees to make eleven (11) monthly payments of \$100, and a final payment of \$34.78. Each payment shall be made on or before the thirtieth (30th)

day of each month, with the first payment due on or before September 30, 2014. As this is a finaled account, PPL Electric will not issue monthly bills. Payments shall be sent to 2 North 9th Street, Allentown, PA 18104, with Account No. 40610-14108 noted on the check. In the event Complainant does not make timely monthly payments, PPL Electric shall have the right to transfer the entire balance to an active account in the name of Complainant.

(b) Complainants withdraw their Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.


