Kindly accept this correspondence as PECO Energy Company's ("PECO Energy's") request to withdraw its Request for Approval of Amended Affiliate Interconnection Agreement ("Interconnection Agreement") filed at Docket No. G-2011-2264873.

On September 26, 2011, PECO Energy filed a Request for Approval of Amended Affiliate Interconnection Agreement at Docket No. G-2011-2264873. Under this filing, PECO Energy requested that the Pennsylvania Public Utility Commission (the "Commission") grant approval, under 66 Pa. C.S. 2102(b), of an Interconnection Agreement between PECO Energy and its affiliate, Exelon Generation Company, L.L.C. ("Exelon Generation") associated with the Schuylkill Generating Station located in Philadelphia, Pennsylvania. The Interconnection Agreement governed the reconfiguration of an interconnection between the Schuylkill Generating Station and PECO's electric distribution system through removing a 13 kV ring bus to interconnect the customers formerly on the ring bus directly to a 69 kV line. PECO Energy requested that the Commission approve the Interconnection Agreement so that the company could implement the Schuylkill Station upgrades in accordance with its construction plans.

It is PECO Energy's position that the Interconnection Agreement is now moot. PECO Energy therefore believes that it is not necessary for the Commission to examine or act on the company's request. PECO Energy therefore respectfully requests permission to withdraw the Request for Approval of Amended Affiliate Interconnection Agreement filed at Docket No. G-2011-2264873.
