



#### **PROCEDURE FOR A FOREIGN CORPORATION TO DO BUSINESS IN PENNSYLVANIA** (Business, Professional and Non-Profit Corporation)

The Pennsylvania Department of State is the granting authority for all foreign corporations to do business in Pennsylvania, and is the storehouse for those papers and other related corporation papers. In order for a non-Pennsylvania corporation to secure authority to do business in Pennsylvania:

- Call the Corporation Bureau, Department of State at (717)787-1057 to determine if the name is available. (Note that this does not reserve the name.)
- 2. If you wish to reserve the name, send a letter or form DSCB:17.3B and a check for \$10 to reserve the name for 60 days.
- 3. Prepare the Application for Certificate of Authority and Registry Statement in the proper format, as prescribed in Title 15, Purdon's Statutes 1204, 1206, or 15 Pa. C.S. 8124 (in the case of non-profit corporations) and exemplified in the forms DSCB-1004 (Application for Certificate of Authority) and BCL-206 (Registry Statement).
- 4. Send the following documents to the Secretary of the Commonwealth, William R. Davis, Room 308, North Office Building, Harrisburg, PA 17120, either by mail or in person:
  - a. Name reservation, if applicable.
  - b. Consent to Appropriation of Name form (17.2) or Consent to Use Similar Name form (17.3), if applicable.
  - c. Application for Certificate of Authority the application will be filed and returned immediately upon receipt by the Bureau.
  - d. Registry Statement in triplicate.
  - e. A certificate of the appropriate official of the jurisdiction under the laws of which the applicant corporation was incorporated, dated within 60 days of delivery of the Application for a Certificate of Authority to the Department, to the effect that the corporation is a corporation duly incorporated and existing under the laws of such jurisdiction.
  - f. A \$150.00 check, draft or money order payable to the Secretary of the Commonwealth in payment of the filing fee.
- 5. Publish in two newspapers of general circulation, in English, in the county where the initial registered office of the corporation is located, either the intention to file or the filing of the Application for Certificate of Authority. One newspaper should be the legal newspaper, if any. These proofs should be kept with the minutes of the corporation.
- 6. The Secretary of the Commonwealth will review, microfilm and return the original Application for Certificate of Authority along with a Certificate of Authority.



#### PROCEDURE FOR A FOREIGN CORPORATION TO DO BUSINESS IN PENNSYLVANIA (Business, Professional and Non-Profit Corporation)

The Pennsylvania Department of State is the granting authority for all foreign corporations to do business in Pennsylvania, and is the storehouse for those papers and other related corporation papers. In order for a non-Pennsylvania corporation to secure authority to do business in Pennsylvania:

- Call the Corporation Bureau, Department of State at (717)787-1057 to determine if the name is available. (Note that this does not reserve the name.)
- 2. If you wish to reserve the name, send a letter or form DSCB:17.3B and a check for \$10 to reserve the name for 60 days.
- 3. Prepare the Application for Certificate of Authority and Registry Statement in the proper format, as prescribed in Title 15, Purdon's Statutes 1204, 1206, or 15 Pa. C.S. 8124 (in the case of non-profit corporations) and exemplified in the forms DSCB-1004 (Application for Certificate of Authority) and BCL-206 (Registry Statement).
- 4. Send the following documents to the Secretary of the Commonwealth, William R. Davis, Room 308, North Office Building, Harrisburg, PA 17120, either by meil or in person:
  - a. Name reservation, if applicable.
  - b. Consent to Appropriation of Name form (17.2) or Consent to Use Similar Name form (17.3), if applicable.
  - c. Application for Certificate of Authority the application will be filed and returned immediately upon receipt by the Bureau.
  - d. Registry Statement in triplicate.
  - e. A certificate of the appropriate official of the jurisdiction under the laws of which the applicant corporation was incorporated, dated within 60 days of delivery of the Application for a Certificate of Authority to the Department, to the effect that the corporation is a corporation duly incorporated and existing under the laws of such jurisdiction.
  - f. A \$150.00 check, draft or money order payable to the Secretary of the Commonwealth in payment of the filing fee.
- 5. Publish in two newspapers of general circulation, in English, in the county where the initial registered office of the corporation is located, either the intention to file or the filing of the Application for Certificate of Authority. One newspaper should be the legal newspaper, if any. These proofs should be kept with the minutes of the corporation.
  6. The Secretary of the Component.
  - 6. The Secretary of the Commonwealth will review, microfilm and return the original Application for Certificate of Authority along with a Certificate of Authority.
