By Commission Order, at Public Meeting held December 2, 1993, in the above docketed proceeding, the Commission reinstated its Order entered August 4, 1992, which approved a transfer of operating rights to the applicant, and which subsequently was rescinded due to failure of the applicant to comply with the Commission's tariff requirements. In granting the petition for reinstatement, the Commission's Order which was entered December 2, 1993, stated that the Order was conditioned upon the applicant's maintaining appropriate evidence of insurance and with the filing of appropriate tariffs.

It is our understanding that tariff adoption supplements were filed in August, 1992, copies of which were attached to the petition to reinstate which the Commission granted.
