ORDER CERTIFYING THE RECORD

On or about June 6, 2007, the Office of Consumer Advocate (OCA) petitioned the Public Utility Commission (PUC or Commission) to immediately institute a proceeding under Section 529 of the Public Utility Code to order a capable public utility to acquire Washington Park Water Company, Inc. and Washington Park Sanitary Company, Inc. (WP Water and WP Sanitary). 66 Pa. C.S. § 529.

The parties entered into mediation and on March 18, 2009, filed a joint Petition for Settlement with the Secretary for the PUC.

Concurrently with the Joint Petition for Settlement, the parties filed a Joint Petition for Certification of the Record and Expedited Treatment of the Settlement. It is in the best interest of the customers and the public that this matter be handled and resolved as quickly as possible.

By Secretarial Letter issued on March 20, 2009, the Commission granted the parties Petition to have the record certified.

IT IS ORDERED:

1. That the Petition for Joint Settlement and the Petition for Certification of the Record and Expedited Treatment is admitted into the record.
2. That the parties listing of the record which appears on pages 9, 10 and 11 of the Petition for Certification of the Record and Expedited Treatment is adopted.
3. That the parties Stipulations appearing on page 11 of the Petition for Certification of the Record and Expedited Treatment are accepted.
4. That the record in this matter is closed.
5. That the record is certified to the Commission for decision.
