

1. The Complaint filed in this proceeding mentions "Direct Energy." No documentation was attached to the Complaint by Zuravleff Inc., T/A Mert's ("Complainant").
2. The Complaint was incorrectly captioned against Direct Energy Services, LLC:
 - a. The Complainant is a business. The Complainant was a customer of Direct Energy Business, LLC. Complainant was not a customer of Direct Energy Services, LLC.
 - b. Direct Energy Services, LLC, is licensed by the Pennsylvania Public Utility Commission (Docket No. A-110164) to provide electric generation supply services to the public in the Commonwealth, including the service territory of PPL.
 - c. Direct Energy Business, LLC, is licensed by the Pennsylvania Public Utility Commission (Docket No. A-110025) to provide electric generation supply services to the commercial, industrial and governmental customers in the Commonwealth, including the service territory of PPL.


