In response to the failure to maintain Liability insurance for my dump truck which is registered with the Pennsylvania Public Utility Commission license number A-2010-22-184 I wish to offer this explanation to you.

I was diagnosed several years ago with Graves Disease, as a result of my Hyperthyroidism. The disease has now begun to affect my eyesight and made driving more difficult. I had to make the difficult decision to sell my truck and make plans for what is next in my life.

It was not an easy choice and it also made it necessary for my wife to find more gainful employment. We found ourselves forced into several life changing plans and set into action what to do.

On July 1, 2014 I sold my truck and the title work was completed to the new owner, Best Used Trucks of PA. I notified my insurance agent on July 2, 2014 the truck had been sold and to cancel my policy effective that day.


When I received the letter from the Pennsylvania Public Utility Commission dated August 7, 2014 I had not realized that notifying the commission was an important step in finalizing the sale of my truck. After discussing this matter with my wife discovered I had assumed she was writing a letter to state the sale and cancel my PUC license. As it turns out she thought I was calling the PUC Commission to cancel.

I apologize for my failure to cancel and realize how important this matter is. Since I never operated my truck without insurance coverage and no longer own this vehicle I request that no fine be imposed on me.

I am including copies of the Sales Agreement from the buyer for my truck along with the notice of cancellation of insurance from my agent at Erie Insurance.

With my not having income since June 2014 I request that the commission please not impose any fines since that would create further hardship for me and my family. Thank you.
