ANSWERS TO NEW MATTER

11-19. Denied. Recent payment history confirms complainant is current paying monthly utility bills. It is averred the charges at issue in the complaint are disputed. In good faith complainant filed the complaint disputing the charges/amounts on the shut off notice because PECO/Exelon Corp. accepted \$247,38 as full and final payment instead of the claimed amount of \$3,373.96. Copy of the front and back of the check accepted and processed for payment are attached and incorporated herein. Pursuant to the above, complainant tried to address and resolve the dispute with

PECO, but to no avail. Due to inability to resolve the dispute and possible termination of services, the complaint had to be filed. It is specifically denied complaint acted in bad faith. Strict proof is demanded as to the remainder of the new matter allegations. The remaining allegations are denied as conclusions of law for which no response is required. The answers to new matter are fully incorporated into complainant's formal complaint.
