12. The buyer has been actively involved with Gastley's Moving and Storage, Inc. since the business was incorporated in 1986. He is both an officer (President) and an employee of the corporation and is greatly responsible for the growth of the family business. Now, due to the age of the Seller, it is the desire of the parties to transfer all of the capital stock of the corporation to the Buyer to ensure the continuation of the family business and to reward the Buyer for his efforts with regard to the business. The transfer will also protect the Buyer as the business represents his economic livelihood.

STATEMENT

Gastley's Moving and Storage, Inc. was incorporated on April 22, 1986 as a Pennsylvania Business Corporation.

Generally, the corporation was created for the purpose of having the unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be organized under the Business Corporation Law of Pennsylvania. Specifically, the corporation was created to engage in business as a common carrier. In 1986, the Public Utility Commission approved the corporation's application at A-00107072 for the transfer of rights formerly held by Harvey C. Gastley at A-0092550. The rights transferred to the corporation were as follows:

"To transport, as a Class B carrier, household goods in use between points in the borough of Gettysburg, Adams County."

"To transport, as a Class D carrier, household goods in use from the borough of Gettysburg, Adams County, to points within two hundred (200) miles by the usually traveled highways of the limits of the said borough, and vice versa."

Since P.U.C. approval and at all times to include the present, the corporation has operated as common carrier consistent with its rights, as stated above, in terms of the service it furnishes to the public and in terms of the territory within which it operates.
