Dear Mr. Radcliff:

The above referenced application has been assigned for review without an oral hearing. In order to reach a determination on the application, you are being required to file verified statements in accordance with 52 Pa. Code §3.381(e)(1). You will be required to file:

- A. VERIFIED STATEMENT OF APPLICANT.
- B. VERIFIED STATEMENTS IN SUPPORT OF APPLICATION.

The verified statements should be in paragraph form. Each heading contained in the attached minimum outline should be a separate section or paragraph.

You should be aware of the fact that the verified statements will be reviewed based on the Commission's decision in the Application of Bluebird Coach Lines, Inc. A-00088807, F. 2, Am-K, which indicates: (1) the supporting witnesses must give evidence which is probative and relevant to the application proceeding; (2) the supporting witnesses must identify Pennsylvania origin and destination points between which they require transportation and those points must correspond with the scope of the operating territory specified in the application including requests for vice versa authority; and (3) the number of witnesses which will represent a cross section of the public on the issue of need will vary with the breadth of the intended territory and commodity description.

You are being granted an initial thirty (30) days to file verified statements. They will be due on or before February 8, 1994.

If additional time is required, it may be requested by telephone but must be followed in writing with the reasons for the extension stated.

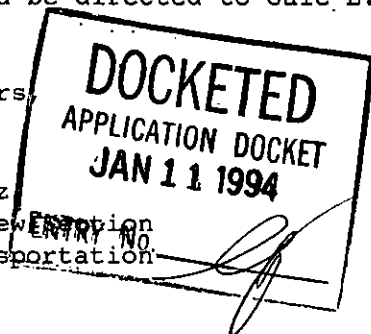



2. IDENTITY AND QUALIFICATIONS OF PERSON MAKING STATEMENT FOR APPLICANT

My name is Michael Gastley. I am the president and a director of the applicant corporation. I am familiar with the equipment, facilities, operations and finances of the company. I am the proper person to give this statement on behalf of the Applicant.

3. IS THE APPLICANT AFFILIATED WITH OTHER CARRIERS?

The applicant is not affiliated with any other certificated carrier.

4. AUTHORITY SOUGHT

By this application Gastley's Moving & Storage, Inc. seeks additional authority for Pennsylvania intrastate service as follows:

The transportation of (1) household goods, personal effects and property used or to be used in a dwelling when a part of the furnishings, equipment or supplies of such dwelling as an incidental part of a removal by the householder from one domicile to another; furniture, fixtures, equipment and the property of stores, offices, museums, institutions, hospitals or other establishments when a part of the stock, equipment or supply of such stores, offices, museums, institutions, hospitals or other establishments, in connection with a removal from one location to another; and articles, in use, including objects of art, displays and exhibits which because of their unusual nature or value require specialized handling and equipment usually employed in moving household goods, between points in the borough of Gettysburg, Adams County, and within fifteen (15) miles of said borough, and from points in said territory, to points in Pennsylvania, and vice versa; and (2) tabulating machines, calculating machines, computers, copying machines, electronic equipment and other business machines and equipment which because of their unusual nature or value require specialized handling and equipment usually employed in moving household goods; and parts, materials and supplies used in connection therewith, between points in the borough of Gettysburg, Adams County, and within fifteen (15) miles of said borough, and from points in said territory to points in Pennsylvania, and vice versa.

The application is unopposed and has been assigned for handling on modified procedure.

5. GENERAL SCOPE OF CURRENTLY AUTHORIZED OPERATIONS

Applicant's current authority from this Commission authorizes the transportation of household goods in use from the borough of Gettysburg, Adams County, to points within two hundred miles by the usually traveled highways of the limits of said borough and vice versa. We have been providing service to the public between points in the borough of Gettysburg and to and from other points in Pennsylvania under this authority.

In this application we are seeking to increase the base territory. We are also adding to the commodities those tabulating machines, computers and electronic equipment items which require specifically stated authority from this Commission within the same territory.

In addition to moving and storage services we offer a partial or complete packing and unpacking service.

6. DUPLICATING AUTHORITY WHICH WILL RESULT FROM GRANT OF AUTHORITY.

7. DUAL OPERATIONS RESULTING FROM GRANT OF AUTHORITY.

Applicant operates only as a common carrier.

8. PERTINENT TERMINAL FACILITIES AND COMMUNICATIONS NETWORK.

Applicant is in the warehousing business as well as providing transportation of household goods. Our storage facility at 224 Table Rock Road, Gettysburg, is available to meet our customers' requirements. However, it is anticipated that most household and office moves will be made direct from the point of origin to the point of destination without utilization of warehouse or terminal facilities.

We have a 50 x 90 foot steel frame and concrete floor warehouse. The warehouse is equipped with storage racks and all upholstered furniture is plastic shrink-wrapped before storage. Warehouse operations are facilitated by the use of a tow motor. Additionally within the warehouse we have fifty-two 7 1/2' x 7 1/2' x 5' wooden storage containers. At the warehouse location we

have office facilities. Telephone lines are available there for the public to reach us to schedule our services.

We provide for maintenance and fuel availability for our equipment through outside services. This use of outside services has proved to be cost effective for the size of our operation.

9. PERTINENT EQUIPMENT

Applicant currently owns and operates one moving van, two tractors and three van trailers and a pickup truck in providing transportation services. The equipment is set forth on Exhibit A attached to this statement.

In addition to the vehicular equipment, Applicant has a full range of accessories for use in household and office moves. The accessorial equipment is also set forth on Exhibit A.

I do not anticipate the need for additional equipment following approval of this application. However, if additional equipment is required, Applicant is financially able to acquire additional vehicles to meet the public demand for service.

10. SAFETY PROGRAM

The safety program is an important part of our overall operation. Driver training is an ongoing program with regular meetings to emphasize general safe operating procedures and to provide specific seasonal and operational safety information. Complete physical examination files are maintained on all drivers. Additionally, we have a drug screening program under which all drivers are checked every two years. In addition to the drug

screening every two years, drivers are subject to random drug screening tests.

All trucks and trailers are subject to a complete DOT inspection every ninety days by a certified mechanic. The drivers do daily inspections of their equipment. All equipment defects are corrected before the equipment is permitted to operate on the highways.

11. TYPE OF SERVICE CURRENTLY PROVIDED TO THE SUPPORTING WITNESS

Applicant presently provides service in Pennsylvania to or from points in the borough of Gettysburg. The supporting witnesses have detailed in their statements the use that they have made of the Applicant in the past.

12. TYPE OF SERVICE TO BE OFFERED

Applicant will continue to provide high quality household and office moving service. Features of our service include the following:

1. On premises review of items to be moved and discussion with customer regarding special handling requirements.
2. Scheduled pickup time.
3. Packing and unpacking service.
4. Same day delivery when distances and loading times permit.
5. Experienced personnel familiar with the proper handling of household and office furniture items.

13. FINANCIAL DATA

I have attached as Exhibit B, Applicant's financial statements as of September 30, 1993. Applicant's assets total more than \$45,100 dollars. Operations for 1993 were profitable.

Applicant is financially sound.

14. WHETHER SERVICE PROVIDED WILL CREATE EMPTY MILES OR BACKHAULS

Moving service is by nature a one way service. Because the service is specifically tailored to the needs of each individual shipper, return traffic is rarely available. Empty miles will result. Rates over forty miles have been set taking into account the exclusive use of the vehicles that are required to provide appropriate service.
