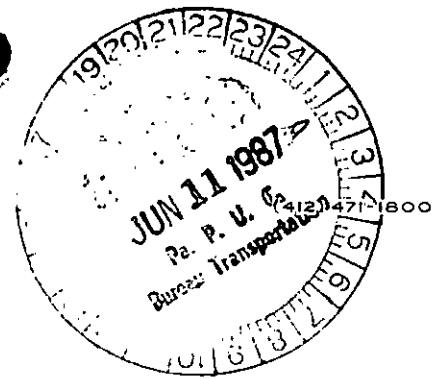

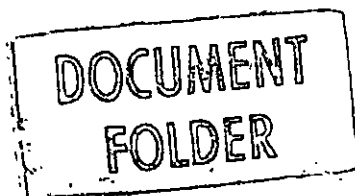

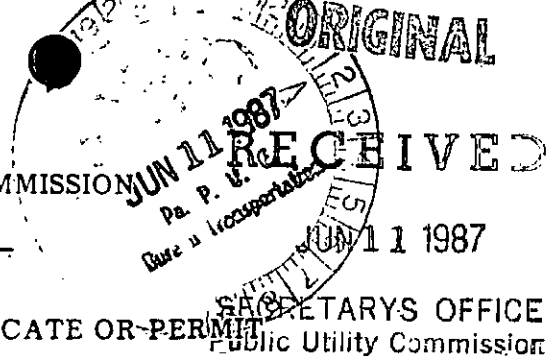

SUPPLEMENT TO PARAGRAPH 9

Charter Purpose Clause

The corporation shall have unlimited power to engage in and to do any lawful act concerning any or all lawful business for which corporations may be incorporated under the Pennsylvania Business Corporation Law of 1933, as amended.
