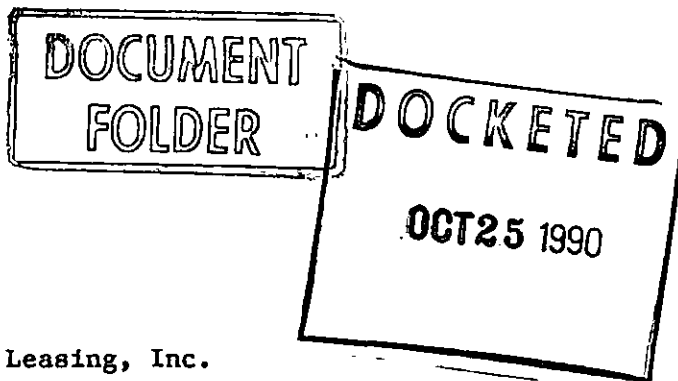


BY THE COMMISSION:
