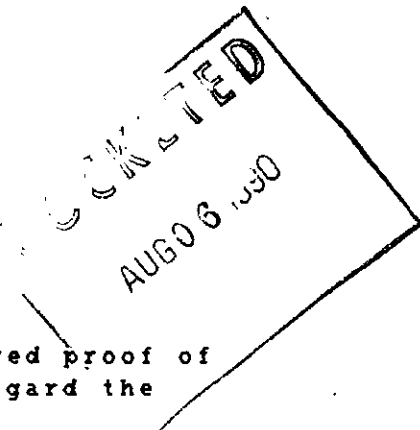

Gentlemen:

During the month of December 1998, Enforcement Officer Jerome M. Todaro conducted a household goods review of your business operations for the months of January 1998 through December 1998.

The following five (5) moves reflect violations of 52 Pa. Code §31.122(2), for failure to use and execute a proper form for estimates of charges titled "Estimated Cost of Services":

- (a) Timothy Ahlstrom, January 31, 1998
- (b) Joseph Wasserman, April 3, 1998
- (c) Mary and Chris Cassano, April 30, 1998
- (d) Lori Race, May 29, 1998
- (e) Bill Peace, September 30, 1998

The shipper shall be given a completed estimate of charges on the proper form as required by 52 Pa. Code §31.122(2), even if an estimate is given over the telephone in advance.

The following three (3) moves reflect violations of 66 Pa. C.S. §1303, by charging a lesser rate than that specified in your household goods tariff on file with this Commission.

- (a) In the household goods move made for Lori Race on May 29, 1998, you charged \$488.75, as opposed to the correct charge of \$510.00, resulting in an approximate undercharge of \$21.25.
- (b) In the household goods move made for Lynn Rogers on July 30, 1998, you charged \$2,073.25, as opposed to the correct charge of \$2,073.80, resulting in an approximate undercharge of \$.55.
- (c) In the household goods move made for Bill Peace on September 30, 1998, you charged \$986.25, as opposed to the correct charge of \$1,012.00, resulting in an approximate undercharge of \$25.75.

Continued operations, as described above, may subject you to penalties which may include the assessment of fines up to \$1,000 per violation.





Gentlemen:

This is in response to your inquiry as to whether your new "Estimated Cost of Services" form is an acceptable document for your company to use in household goods service requests.

The purpose of this letter is to advise you that we have identified three (3) problem areas contained in the document. The first problem is that the letters of the title of the document, "Estimated Cost of Services" are too small. The words "Estimated Cost of Services" shall be imprinted across the top of each form in letters not less than 1/2 inch high. Secondly, your "Estimated Cost of Services" form failed to specify/contain the following information: "Shipments of distances over 40 miles are estimated in weight and mileage". Finally, your "Estimated Cost of Services" form failed to specify/contain the information for a shipper, who would request insurance valuation of more than thirty cents (\$.30) per pound per shipment.

For your assistance, I am enclosing a copy of a "Estimated Cost of Services" form, which contains all the necessary information that we require by regulation.

Your "Estimated cost of Services" form, unfortunately, does not meet with the Commission's criteria. Therefore, you are directed to correct the problems/deficiencies with the form immediately. Failure to comply could result in monetary penalties and/or the cancellation of your certificate of public convenience.
