The above referenced application has been assigned for review without oral hearing. In order to reach a determination on the application, you are being required to file verified statements in accordance with 52 Pa. code Section §3.381(e)(1). You will be required to file:

- A. VERIFIED STATEMENT OF APPLICANT
- B. VERIFIED STATEMENT(S) IN SUPPORT OF THE APPLICATION.

The verified statements should be in paragraph form. Each heading contained in the attached minimum outline should be a separate section or paragraph.

You should be aware of the fact that the verified statements will be review based on the Commission's decision in the Application of Blue Bird Coach Lines, Inc., (A-00088807, F. 2, Am-K) 72 Pa. P.U.C. 262 (1990), which indicates: (1) the supporting witnesses must give evidence which is probative and relevant to the application proceeding; (2) the supporting witnesses must identify Pennsylvania origin and destination points between which they require transportation and those points must correspond with the scope of the operating territory specified in the application, including requests for vice versa authority; and (3) the number of witnesses which will represent a cross section of the public on the issue of need will vary with the breadth of the intended territory and commodity description.

You are being granted an initial thirty (30) days to file verified statements. They will be due on or before August 29, 1994.

If additional time is required, it may be requested by telephone but must be followed in writing with the reasons for the extension stated. Questions about the application should be directed to Tim Zeigler at 717-783-5946.

VERIFIED STATEMENT OF JAMES DANIELEWICZ

1. Applicant is James Danielewicz, t/d/b/a Limousines for Less, with a business address at 315 Clermont Avenue, Stroudsburg, Pennsylvania 18360.

2. My name is James Danielewicz and I am sole proprietor. The trade name "Limousines for Less" has been duly registered with the Department of State of the Commonwealth of Pennsylvania. As the owner of my business, I am thoroughly familiar with its proposed operations, equipment and facilities and I am authorized to appear and present this Verified Statement.

3. The Applicant is not affiliated with any other carriers.

4. As originally filed, this application sought the right to transport persons in limousine service between points in the counties of Monroe and Pike, and from points in said counties to

points within an airline distance of fifty (50) statute miles of the limits thereof, and vice versa.

The application, as finally amended, seeks the following right:

To transport, as a common carrier, persons, in limousine service, between points in the Counties of Monroe and Pike, and from points in said counties, to points within an airline distances of ten (10) statute miles of the limits thereof, and vice versa;

Subject to the following conditions:

- (1) That no right, power, or privilege is granted to originate service in the counties of Lehigh and Northampton, except as presently authorized; and
- (2) That no right, power, or privilege is granted to originate service from points in the county of Monroe which are located more than ten (10) statute miles of the limits of the Borough of Stroudsburg.

As a consequence of the Restrictive Amendment, all protests to the application have been withdrawn.

5. I presently hold authority from this Commission to provide transportation in limousine service from points within an airline distance of ten miles of the limits of the Borough of Stroudsburg to the Allentown/Bethlehem/Easton airport, and vice versa. I also recently received airport transfer authority which permits service from points in the counties of Monroe, Pike, Wayne, Lackawanna and Carbon, to the Wilkes-Barre/Scranton airport, the Allentown/Bethlehem/Easton airport, and the Philadelphia International Airport.

I also hold authority from the Interstate Commerce Commission docketed to MC-197034.

6. There would be a partial duplication of my current operating rights by approval of this application, since I can presently originate limousine service from points within ten miles of Stroudsburg to the Allentown/Bethlehem/Easton airport, and vice versa.

7. Application's administrative offices and terminal facilities are located at its principal place of business, 315 Clermont Ave., Stroudsburg, Monroe County, Pennsylvania. At that facility we have dispatch facilities, office facilities, vehicle storage facilities and all necessary related equipment for the provision of certificated service. The office also has telephone service in order for persons desiring the service to make the necessary arrangements. The facility is conveniently located for the provision of service between all points in the application territory and from that territory to the authorized destination territory and vice versa.

8. The vehicles which I presently operate in certificated service are the same vehicles that would be used in connection to the service proposed. They are identified as follows:

A 1985 white Lincoln Stretch Limousine; a 1985 black Lincoln Stretch Limousine; a 1988 silver Lincoln Stretch Limousine; a 1988 blue Town Car; a 1988 silver Town Car; and a 1992 GMC 15 passenger delux van.

9. Applicant maintains a comprehensive safety program which includes the screening and safety training of drivers, and emphasizes preventive maintenance as well as compliance with all

federal, state and local safety regulations. We will continue to emphasize safety in all phases of our operations.

10. Applicant presently provides service to the supporting witnesses only for transport to airports, under existing limousine rights and airport transfer rights.

11. The type of service which will be offered should the present application be granted will be limousine service, conducted in accordance with the Commission's Regulations and the scope of the authority granted.

12. As evidence of its financial fitness, Applicant incorporates his most recent annual report to the Commission.


