The category 'Mixed Meter' has recently been added as a customer class, but was not an option on the application that EDFES originally completed. The selection of Small Commercial customers on the original application was chosen in preparation for Mixed Meter situations. For this reason, EDFES has decided to remove the Small Commercial customer class from its application, and add the Mixed Meter customer class. The following page reflects this amendment.
