**PREHEARING ORDER #9 ON REMAND-GRANTING QWEST COMMUNICATIONS
COMPANY'S PETITION FOR LEAVE TO WITHDRAW INTERVENTION**

On June 8, 2011, Qwest Communications Company's ("QCC"), through its counsel, John F. Povilaitis, Esquire, filed a Petition for Leave to Withdraw Intervention. In the Petition it was noted that after the Commission lifted its stay of the access charge investigation, QCC submitted a prehearing memorandum stating that "Qwest will be actively monitoring the proceeding to protect its interest, but does not have any issues to identify and bring forward at this time." QCC has not served any testimony in the reactivated docket. QCC indicated that the withdrawal will not adversely affect any other party in the proceeding and it will not affect the outcome of the contested issues in this case. Therefore QCC requested that it be allowed to withdraw its intervention and that counsel for QCC, Mr. Povilaitis and Douglas Hsiao, Esquire, be removed from the service list.

Counsel for the parties in this proceeding indicated that they have no objection to the Petition for Leave to Withdraw Intervention. Accordingly, the Petition is granted.

ORDER

THEREFORE,

IT IS ORDERED:

1. That the Petition for Leave to Withdraw Intervention filed by Qwest Communications Company's is granted.

2. That the names of John F. Povilaitis, Esquire, and Douglas Hsiao, Esquire, counsel for Qwest Communications Company, be removed from the service list in this matter.
