5. A date-stamped copy of the Articles of Amendment form filed with the Pennsylvania Department of State.

Upon the submission of this information to the Commission, the Commission will endorse your existing certificate, permit or license in the new name with no change to your existing docket number. Within 30 days of this endorsement, you must make the necessary changes on your insurance and tariff filings with the Commission.
