PURSUANT TO 52 PA. CODE § 5.24(B)(2)**

AND NOW, comes United Water Pennsylvania Inc. (“United”), by its attorneys, and, submits this Certified Writing, pursuant to 52 Pa. Code § 5.24(b)(2), acknowledging that Complainant Insurance Company of Greater New York A/S/O Quail Run Real Estate LP D/B/A Quail Run Apartments (“INSCO”) no longer wishes to pursue its Complaint in the above consolidated matters and further stating as follows:

1. On November 22, 2013, INSCO filed a formal Complaint with the Pennsylvania Public Utility Commission (“Commission”) against United, which was later amended pursuant to an Amended Complaint filed with the Commission on May 7, 2014.¹ United timely filed Answers with New Matter to both the Complaint and the Amended Complaint.

¹ The INSCO Complaint was assigned Docket No. C-2013-2393832 and, by Order Granting Motion To Consolidate Complaints, dated May 29, 2014, was consolidated with the Complaint of State Farm Fire and Casualty Company (“State Farm”) at Docket No. C-2014-2416206. The State Farm complaint docket has since been closed.

2. On October 14, 2014, the parties reached an accord resolving all issues arising from the Complaint, as amended.

3. United certifies pursuant to 52 Pa. Code § 5.24(b)(2) that INSCO has acknowledged that it no longer wishes to pursue its Complaint, as amended.

4. In accordance with 52 Pa. Code § 5.24(c), INSCO is hereby informed that it has the right to object, in writing, to this Certified Writing, within ten (10) days and that, unless INSCO objects, in writing, within ten (10) days, the Commission's Complaint Docket at C-2013-2393832 will be marked closed.


