We are writing in accordance with our telephone conversation this morning with Tatayna Roth who is in the Commission's Bureau of Investigation and Enforcement. We represent Kreider Brothers, Transit, Inc. (A-00118-176 Kreider).

Kreider ceased operations prior to August 1, 2014. When it ceased operations, Kreider so notified the Commission by telephone and was advised not to file any formal paperwork regarding cessation of its operations. Thereafter, it notified its insurance carrier that it was out of business. The insurance carrier then cancelled the insurance and so notified the Commission. Kreider never operated without insurance required by the Commission.

After receiving the Complaint, Kreider realized that it was required to notify the Commission in writing of the cessation of its operations. It has done so by the notice attached hereto. As a precaution, Kreider is filing an Answer to the Complaint. It desires, however, that

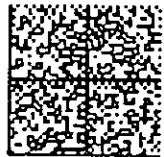
