

AMENDED PRE-HEARING STATEMENT OF SNYDER BROTHERS, INC.

Snyder Brothers, Inc. ("SBI") hereby files the following Amended Pre-Hearing Statement:

DOCUMENTS:

SBI may offer any exhibit attached to SBI's Answer or identified during the Deposition of Yvonne Hess and documents which establish that certain wells permitted as "unconventional" were not completed/operated as such for the period(s) when the Complainant contends fees are due for these wells.

VI. WITNESSES

SBI intends to present direct, rebuttal, and surrebuttal testimony as may be necessary. It also reserves the right to have certain witnesses deemed "hostile" for purposes of their testimony. SBI will present testimony in oral form and offer exhibits, documents and explanatory information.

In addition those potential witnesses previously listed SBI may also call Benjamin Snyder, an officer of SBI, whose address is P.O. Box 1022, Kittanning, PA 16201, who if called will testify concerning his knowledge of SBI's efforts to comply with the requirements of Act 13 relating to impact and administrative fees.

Other representatives of the PUC and other witnesses not yet identified.

SBI reserves the right to call additional witnesses, as necessary and to designate one or more witnesses as an “expert” in the area of gas well operation and production . Once such additional witnesses are identified SBI will notify the presiding Administrative Law Judge and all parties of record.


