Pursuant to the Pennsylvania Public Utility Commission ("Commission") Secretarial Letter issued in the above referenced docket on September 5, 2014, Duquesne Light Company ("Duquesne Light" or "Company") hereby submits an update regarding the status of its 2014-2016 Universal Services and Energy Conservation Plan ("2014-2016 USECP") implementation.

The Company's 2014-2016 USP was approved by the Commission on March 6, 2014. Since that time, the Company has implemented all the approved changes except those items for which the Company was granted an extension on September 5, 2014. As explained in the Company's request for extension, implementation of these remaining items is directly tied to the implementation of the Company's Customer Care & Billings ("CC&B") system. Presently, the Company anticipates that it will be able to implement the remaining 2014-2016 USP changes by December 1, 2014 as required, subject to the successful implementation of the CC&B system. The Company will notify the Commission and parties of record as soon as possible should it encounter any delay in implementing these requirements.

## UPS CampusShip: View/Print Label

1. **Ensure there are no other shipping or tracking labels attached to your package.** Select the Print button on the print dialog box that appears. Note: If your browser does not support this function select *Print from the File menu to print the label.*
2. **Fold the printed sheet containing the label at the line so that the entire shipping label is visible.** Place the label on a single side of the package and cover it completely with clear plastic shipping tape. Do not cover any seams or closures on the package with the label. Place the label in a UPS Shipping Pouch. If you do not have a pouch, affix the folded label using clear plastic shipping tape over the entire label.
3. **GETTING YOUR SHIPMENT TO UPS**  
UPS locations include the UPS Store<sup>®</sup>, UPS drop boxes, UPS customer centers, authorized retail outlets and UPS drivers.  
Schedule a same day or future day Pickup to have a UPS driver pickup all your CampusShip packages.  
Hand the package to any UPS driver in your area.  
Take your package to any location of The UPS Store<sup>®</sup>, UPS Drop Box, UPS Customer Center, UPS Alliances (Office Depot<sup>®</sup> or Staples<sup>®</sup>) or Authorized Shipping Outlet near you. Items sent via UPS Return Services(SM) (including via Ground) are also accepted at Drop Boxes.
