The Commission in a public meeting on August 26, 2005 ordered that the proposed tariff revisions to Supplement No. 94 to Tariff-Telephone Pa. P.U.C. No. 24, which were filed on May 18, 2005, to become effective September 1, 2005 shall become effective as filed.


The Commission also ordered that the proposed tariff revisions to Supplement No. 87 to Tariff-Telephone Pa. P.U.C. No. 23, which were filed on May 18, 2005, to become effective September 1, 2005 be suspended for a period not to exceed six months, or until March 1, 2006, pursuant to 66 Pa. C.S. § 1308.

Under the Public Utility Code, a supplement must be filed with the Commission and posted at the offices of the company to announce that the aforementioned Supplement is suspended until the date stated in the Commission's Order.

Attached is a sample copy of a six months suspension supplement which must be filed in triplicate with the Commission as soon as possible.

It was also ordered that company be given the alternative to file, within ten (10) days after the entry date of the Opinion and Order, a revised tariff supplement, which cancels and supersedes the tariff revisions which were filed. If such a tariff is filed, it shall be permitted to become effective on one-day's notice, the suspension shall be terminated.

It was further ordered that if the company elects not to file a revised tariff, then an investigation will be instituted and the matter assigned to an Administrative Law Judge for a Recommended Decision.
