To transport, as a common carrier, by motor vehicle, household goods in use, from points in the borough of Waynesboro, Franklin County, and within fifteen (15) miles by the usually traveled highways of the limits of the said borough, to points in Pennsylvania within one hundred seventy-five (175) miles by the usually traveled highways of the limits of the said borough, and vice versa; and household goods in use, between points in the borough of Waynesboro, Franklin County, and within an airline distance of three (3) statute miles of the limits of the said borough.
