Dear Secretary Chiavetta:

On March 6, 2013, PAWC filed an application to acquire the HTMA's wastewater system serving the public in portions of Hamiltonban Township, Adams County. On October 2, 2013, PAWC filed an Amendment to its original application seeking the Commission's permission to revise the application by clarifying HTMA's service territory to include a portion of Highland Township, Adams County. On December 5, 2013, the Commission entered an Order that a Certificate of Public Convenience be issued, upon notice of closing, to begin to furnish wastewater service to the public in portions of Hamiltonban Township, Adams County.

PAWC closed on the acquisition on November 3, 2014. Enclosed, for the Commission's record, is a copy of the Agreement the parties had executed to extend the closing date.

Pursuant to Ordering Paragraph 3 of the December 5, 2013 Order, PAWC is requesting a Certificate of Public Convenience be issued evidencing the Commission's approval to furnish wastewater service to the public in portions of Hamiltonban Township, Adams County as well as the several customers that are located in Highland Township, Adams County. These areas were outlined on the Amendment's revised map at Exhibit L and updated Exhibit M, description of the area served.

ARTICLE 3, SECTION 3.1 Closing is hereby amended to change the closing date from September 30, 2014 to October 30, 2014.


All other covenants and conditions of the aforementioned Purchase Agreement shall remain unchanged.




