AND NOW, comes Respondent Greg Albright and Personal Touch Transportation (“Respondent”), by its attorney, and, submits this Certified Writing pursuant to 52 Pa. Code § 5.24(b) in the above complaint matter, stating as follows:

1. On or about August 13, 2014, Complainant Jim Salinger (“Complainant”) filed a formal Complaint with the Pennsylvania Public Utility Commission (“Commission”) against Respondent. On November 3, 2014, Respondent timely filed an Answer to the Complaint.
2. By Interim Order Setting Resolution Conference dated November 7, 2014, Administrative Law Judge David A. Salapa directed the parties to hold a conference in an attempt to resolve the matter themselves and to subsequently file a short report with the Commission’s Mediator within ten days following the conference.
3. The parties convened a telephonic resolution conference on November 14, 2014, where they were able to reach a full and satisfactory resolution of all issues in the case. At the conclusion of the conference, Complainant acknowledged to the undersigned counsel that

Respondent had satisfied the Complaint and that Complainant no longer wished to pursue his Complaint.

4. On November 21, 2014, Respondent filed a short report with the Mediator advising of the status and resolution of the matter.

5. Accordingly, Respondent certifies pursuant to 52 Pa. Code § 5.24(b) that it has addressed the Complaint, that Complainant has acknowledged satisfaction of the Complaint to Respondent, and that Complainant has also acknowledged that he no longer wishes to pursue the Complaint.

6. In accordance with 52 Pa. Code § 5.24(c), Complainant is hereby informed that he has the right to object, in writing, to this Certified Writing, within ten (10) days and that unless Complainant objects, in writing, within ten (10) days, the Commission's Complaint Docket at C-2014-2443617 will be marked closed.
