Dear Secretary:

It was announced on July 30, 2014 that Exelon Corporation ("Exelon") and Integrys Energy Group, Inc. entered into a definitive agreement for Exelon to purchase Integrys Energy Services, Inc. ("IES"). The transaction was conditioned on approval by the Federal Energy Regulatory Commission and the notification and reporting requirements under the Hart-Scott-Rodino Act. The transaction closed effective November 1, 2014.

Pursuant to 52 Pa. Code § 54.34, Constellation NewEnergy, Inc. ("CNE"), Constellation Energy Power Choice, Inc. ("CEPC) and IES submit this notice regarding changes to information supplied in their applications to supply electricity. IES is now an affiliate of CNE and CEPC.

Attachment A provides a post-closing retail energy entity organization chart. Attachment B provides updated regulatory contact information for IES which is the same as CNE and CEPC's current regulatory contact. Attachment C provides an updated list of officers and directors for IES.

Exelon will be assuming the financial responsibility of IES and an updated letter of credit will be provided as required.
