Dear Secretary Chiavetta:

On February 24, 2014, PECO Energy Company ("PECO") filed with the Pennsylvania Public Utility Commission Supplement No. 97 to Electric PA P.U.C. No. 4. On March 26, 2014, the Commonwealth Court of Pennsylvania granted the Emergency Application for Stay pending appeal filed by several intervening parties. The Stay applies to the Commission's Implementation Orders issued on January 24, 2014 and March 12, 2014. As a result, on April 11, 2014, PECO voluntarily postponed the effective date of this tariff until May 15, 2014. PECO requested an additional voluntarily postponement on May 14, 2014 as a final decision regarding the appeal was still not issued.

PECO is again requesting a further postponement of this tariff supplement until a decision is issued. If the Stay is resolved prior to this postponement PECO will refile the tariff upon issuance of the Order. PECO therefore requests to voluntarily postpone the effective date of this tariff until June 30, 2015.

Accordingly, PECO encloses for filing with the Commission Supplement No. 115 to Tariff Electric No. 4 which is being filed to become effective on December 16, 2014.
