Duquesne Light Company (“Duquesne Light” or the “Company”) hereby provides an update regarding the status of its FOCUS Project and Phase 1 Solution, as provided in the Pennsylvania Public Utility Commission’s Order on December 4, 2014 in Docket No. P-2014-2448863.

The Company’s FOCUS System went live on November 28, 2014 as planned. At this time, the Company has determined that it will not be able to successfully integrate the off-cycle switching (“OCS”) Phase 1 Solution with FOCUS by December 15, 2014, due to multiple critical system modifications to the original FOCUS design that have been identified as necessary to integrate the OCS application with the FOCUS System. The Company is also filing today a Petition for Reconsideration/Rehearing which further explains the status of the Company’s implementation of OCS.


