PROTEST OF EXTREME HEALTH CARE SERVICES, LLC T/A GENESIS LIMOUSINE SERVICE

NOW COMES Extreme Health Care Services, LLC t/a Genesis Limousine Service ("Genesis") and files, pursuant to 52 Pa. Code §3.381(c), this Protest to the above-captioned application. In support thereof, represents as follows:

1. The name of the Applicant and the Docket No. assigned to the application are:

- 4. Genesis holds Pennsylvania Public Utility Commission ("Commission") limousine authority under Docket No. A-2012-2336498. A description of the authority currently held by the Protestant, as well as a copy of the Commission Order granting said authority, is attached hereto as Appendix A.
- 5. Genesis is authorized to provide limousine service in Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry and York Counties, Pennsylvania. The Applicant is seeking authority to provide limousine service throughout the Commonwealth of Pennsylvania. Accordingly, the territory in which Genesis is authorized to serve includes portions of the territory sought by the Applicant (Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry and York Counties) in this proceeding.
- 6. The information included in the application is insufficient to allow for a full evaluation of the Applicant's technical, financial and legal fitness to provide the proposed service throughout the territory sought. Accordingly, the Applicant may not possess the requisite fitness to provide the service sought in the application.
- 7. Genesis respectfully requests that the application be set for oral hearing and that the Applicant be required to prove by competent evidence the elements of proof required by statute for authority to provide limousine service in Pennsylvania.
- 8. Genesis will agree to withdraw its protest if the Applicant agrees to eliminate Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry and York Counties from its application.

WHEREFORE, Genesis respectfully requests that (1) approval of the instant application

be withheld, (2) the proceeding be assigned for oral hearing with leave for Protestant to

participate fully therein, and (3) the Applicant be required to present at hearing competent

witnesses for examination on all material and necessary facts bearing on this application.

ORDER

BY THE COMMISSION:

This matter comes before the Commission on an application filed November 28, 2012. Public notice of the application was given in the *Pennsylvania Bulletin* of April 13, 2013 with protests due by April 29, 2013. No protests were filed. The unopposed application is certified to the Commission for its decision without oral hearing. The record consists of verified information submitted with the application.

DISCUSSION AND FINDINGS

Extreme Health Care Services, LLC t/a Genesis Limousine Service ("Extreme" or "Applicant") seeks to begin providing limousine service. Applicant has no prior history of noncompliance with Commission regulations and has no outstanding fines.

Lamont Palmer, Sr. serves as the owner and president for the limited liability company. He has owned and operated Harrisburg City Cabs, Inc. from October 2007 to the present. Previously, he was a manager for Penn Central Taxi for two years. Mr. Palmer also has rental properties and a certified day care.

Applicant's main building, located at 2005 Clayton Avenue, Harrisburg, PA 17109, includes a two car garage and three offices. The office will be equipped with filing cabinets containing PUC and business records, computers, phones, fax machines and copiers. All customer requests for transportation will be obtained through a two way radio system and cell phones which the driver will always carry to maintain continuous communication. The business hours will be 24 hours per day, seven days a week, 365 days a year.

Extreme will utilize one mechanic to service the vehicles with routine and preventative maintenance. One dispatcher will be handling phone calls, routing trips, invoicing clients, paying bills and servicing the drivers.

Prospective drivers' name and license number will be submitted to the insurance company for review. The driver is expected to be over 25 years old and have a solid driving history. Minor violations will be reviewed by the underwriter for final approval. If a driver has repeat offenses, then they will not be approved to be on the company's policy.

New drivers will have a minimum of eight hours of training with an experienced driver while experienced drivers will be trained for a minimum of four hours with another experienced driver. Periodic checks will be performed to ensure that drivers are properly licensed at all times. The Applicant will maintain a drug free work zone by providing a zero tolerance for anyone using illegal drugs. Regular reviews will be performed on drivers' files to confirm all paperwork/lease/background checks.

Applicant plans on purchasing two 2010 Lincoln Town Cars with a seating capacity of 3 passengers.

Vehicles will be maintained with onsite mechanics by having oil changes, tire rotations, brake changes, etc., on a regular basis and will continuously comply with Pennsylvania's equipment standards that are applicable to the type of vehicles used in the business. Each vehicle will be inspected for oil, tires, brakes, and other issues as required. Routine inspection checks of all limousines will be performed to maintain PUC standards. Applicant plans on purchasing newer model vehicles for the limousine service while office staff will maintain records and file annual vehicle lists.

Applicant's member, Lamont Palmer, Sr., currently has over 65 taxicabs with Harrisburg City Cab, Inc. and is insured through American Country Insurance Company.

Extreme will provide service with excellence by being courteous, timely and service oriented. Any customer concerns will be immediately addressed to bring resolution in a timely manner.

The most recent financial data of Applicant is a balance sheet dated October 12, 2012, showing total assets of \$252,500 and no liabilities.

We advise the Applicant to become familiar with the requirements of 52 Pa. Code as applicable to the operation of a common carrier as authorized by this grant of authority. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of authority. Title 52 of the Pennsylvania Code may be accessed at www.pacode.com.

In particular, we urge the Applicant to become familiar with the regulations at 52 Pa. Code §29.333(e) Vehicle Age and 52 Pa. Code §29.503 Age Restrictions. Effective January 1, 2008, vehicles operating in limousine service may not be more than 8 model years old, unless otherwise permitted by the Commission. A common or contract carrier may not permit a person to operate a vehicle in its service unless that person is at least 21 years of age.

After complete review of the record, we find:

- 1. Applicant seeks the initial right to provide limousine service.
- 2. Applicant has the equipment, experience and fitness to provide the proposed service.
- 3. Approval of the application is necessary for the accommodation and convenience of the public: **THEREFORE**,

IT IS ORDERED: That the application for limousine authority is hereby approved and that a Certificate of Public Convenience be issued granting the following right:

to transport, as a common carrier, by motor vehicle, persons in limousine service, from the counties of Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon, Perry and York, to points in Pennsylvania, and return, excluding service that is under the jurisdiction of the Philadelphia Parking Authority.

IT IS FURTHER ORDERED: That the applicant shall not engage in any transportation authorized by this Order until the Applicant has received a Certificate of Public Convenience from the Commission.

IT IS FURTHER ORDERED: That a Certificate of Public Convenience shall not be issued until the following are submitted to the Commission and approved by the Commission:

1. An acceptable Form E, as evidence of bodily injury and property damage liability insurance.

- 2. An acceptable tariff establishing just and reasonable rates.
- 3. An acceptable vehicle list which includes make, model, year and vehicle identification number.

IT IS FURTHER ORDERED: That upon compliance with the requirements above set forth, a Certificate shall issue evidencing the Commission's approval of the right to operate as above-determined.

IT IS FURTHER ORDERED: That the authority granted herein, to the extent that it duplicates authority now held by or subsequently granted to the Applicant, shall not be construed as conferring more than one operating right.

IT IS FURTHER ORDERED: That in the event said Applicant has not, on or before sixty (60) days from the date of entry of this Order, complied with the requirements hereinbefore set forth, the Application shall be dismissed without further proceedings.
