

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Weekdays: (Any Hour): Two and one-half hours at rates named in Columns 1 and 3; and Saturdays (Any Hour): 4 hours at rates named in Columns 1 and 4.

NOTE AA - When distance from original point of origin to final destination is:

- (a) Fifteen (15) miles or less - flat charge shall be one-half hour at the applicable rates.
- (b) Over 15 miles but less than 30 - flat charge shall be one hour at the applicable rates.
- (c) Thirty (30) miles (to 40 miles inclusive) - flat charge shall be one and one-half hours at the applicable rates.
