RESTRICTIVE AMENDMENT



Subject to the following condition:

That no right, power or privilege is granted to provide service from the Pittsburgh International Airport located in Findlay Township, Allegheny County.

Applicant's existing authority at PUC No. A-6411247 shall be unaffected by the foregoing.

**JOINT STIPULATION REGARDING RESTRICTIVE AMENDMENT
AND WITHDRAWAL OF PROTESTS AND OPPOSITION**

Applicant, Cindy's Carriages, LLC ("Applicant"), and Protestants, Airlines Acquisition Co., Inc. t/d/b/a Airlines Transportation Company, Airport Limousine Service, Inc. t/d/b/a Checker Cab, Pittsburgh Cab Company, Inc. t/d/b/a Metro Taxi, Ray Ray Cab Company, LLC t/d/b/a Pittsburgh City Cab, Yellow Cab Company of Pittsburgh, Classy Cab Company, Inc., and Cranberry Taxi, Inc. t/d/b/a Veteran's Taxi (together, "Protestants"), by and through their respective undersigned counsel, stipulate and agree as follows:

1. Applicant has agreed to enter into a restrictive amendment in connection with its Application for Motor Common Carrier of Persons Upon Call or Demand (Taxi Service), filed on April 29, 2014 (the "Application"), restricting the geographic area as to which expanded authority is being sought by Applicant. The text of the restrictive amendment was read into the record at the initial hearing in this action before the Honorable Jeffrey A. Watson on October 21, 2014, and a typed version is being filed contemporaneous herewith, with a copy attached hereto as Exhibit A.

2. The parties stipulate and agree that the Restrictive Amendment is in the public interest, as it withdraws from the authority being sought certain geographic areas which Applicant has no present intention to serve. Moreover, the restriction is anticipated to make more likely the

approval of the Application, the result of which will be additional call or demand service, for which Applicant submits, and stands ready to demonstrate if necessary, there exists a public need.

3. Based upon the Restrictive Amendment and conditioned upon the acceptance of same by the Public Utilities Commission, and any grant of expanded authority being consistent with same, Protestants stipulate and agree to withdraw their filed protests and opposition to the Application.

4. Based upon the foregoing, Applicant has agreed to the submission of its Application to the Public Utilities Commission for further processing, without the need for the taking of evidence at an initial hearing.

5. In the event of rejection of the Restrictive Amendment, the parties reserve the right to proceed with an evidentiary hearing before an Administrative Law Judge. In the event of acceptance of the Restrictive Amendment but where there is anything less than outright approval of Applicant's Application, Applicant reserves the right to supplement its Application with additional evidence in support of the Application, as may be permitted.

6. Protestants, through their respective undersigned counsel of record, shall remain parties of record for the purpose of receiving copies of all future notices and orders in this action.






