DOCUMENT

BY THE COMMISSION:

On April 2, 2004, Glyphics Communications, Inc. ("Glyphics") filed an Application for a Certificate of Public Convenience pursuant to Section 1102(a)(2) of the Public Utility Code, 66 Pa. C.S. §1102(a)(2), evidencing Commission approval to Discontinue and Abandon Service as a Reseller of Interexchange Toll Service (IXC) to the Public in the Commonwealth of Pennsylvania. Glyphics requested a waiver of the \$350 application fee under 52 Pa Code §1.91.

Glyphics is currently certificated to provide telecommunications services as a Reseller of Interexchange Toll Service within the Commonwealth of Pennsylvania, at Docket No. A-310811. Glyphics' certificate was granted on July 15, 1999. Glyphics proposes to abandon its Certificate of Public Convenience and no longer offer IXC service in Pennsylvania. Glyphics states that it ceased providing long distances service in

July 2003 and all existing customers were transferred to Buyers Unlimited, Inc. There are no NXX codes associated with IXC authority, therefore, there are no NXX codes affected by this Application.

No protests have been filed since the Application was filed and no hearings were held. In addition, no motion or petition has been filed in this proceeding.

Upon full consideration of all matters of record pertaining to the Application, we find that approval of the Application would not be detrimental to the public interest;
THEREFORE,

IT IS ORDERED:


1. That the Application of Glyphics Communications, Inc. is hereby approved.
2. That Glyphics Communications, Inc.'s request for waiver of the application fee is granted.
3. That a Certificate of Public Convenience be issued pursuant to 66 Pa. C.S. §1102(a)(2) authorizing the Discontinuance and Abandonment of Service by Glyphics Communications, Inc. as a Reseller of Interexchange Toll Service to the Public in the Commonwealth of Pennsylvania, as specified in the Application.
4. That a copy of this Order be served upon the Office of Consumer Advocate, the Office of Small Business Advocate, the Office of Trial Staff and the Attorney General's Bureau of Consumer Protection.

5. That a copy of this Order be served on the Department of Revenue, Bureau of Corporation Tax.

6. That the Secretary's Bureau is directed to remove Glyphics Communications, Inc.'s tariff and annual report from the shelf and delete the Company's name from the assessment files.

7. That this case be marked closed.

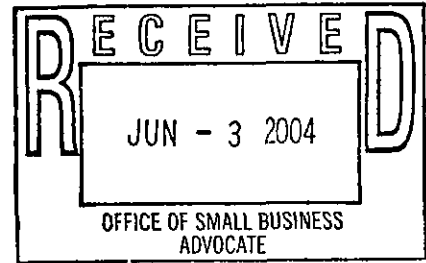
