It has recently come to our attention that Nutel Phone Service, Inc. (Nutel) has applied to the PA Commission for authorization to provide local exchange service in the Commonwealth of Pennsylvania as a competitive local exchange carrier (CLEC). While the application was submitted to the Commission on June 8, 1999, Bell Atlantic - Pennsylvania (BA-PA) was not served with a copy of the application. On August 23, 1999, the Commission itself served BA-PA with a copy of the application, extended the protest period until September 7, 1999, and notified Nutel that they had been granted provisional authority to provide telecommunications service in Pennsylvania.

While BA-PA is not formally protesting Nutel's application, we note and would like to bring to the Commission's attention two inaccuracies contained in the application. On page 3, item 6 of the application, Nutel has identified BA-PA as an affiliate of the applicant doing business in PA. BA-PA and Nutel are not affiliates. On page 5, item 8 of the application, Nutel again identifies BA-PA as an affiliate and also states that an affiliated interest agreement with BA-PA is on file. BA-PA does not have an affiliated interest agreement with Nutel. However, BA-PA and Nutel did file a joint petition for approval of an interconnection agreement on January 26, 1999, which perhaps Nutel has mistaken as an affiliated interest agreement.

BA-PA requests that the Commission instruct Nutel to amend their application to correct these errors.


