

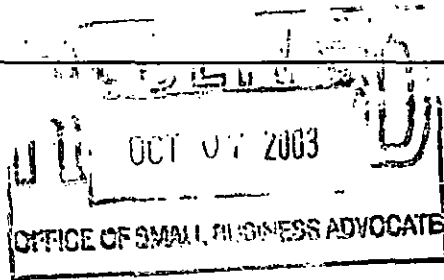

Dear Mr. McNulty:

I am writing on behalf of Verizon Pennsylvania Inc. and US LEC of Pennsylvania Inc. to jointly request an extension of the Commission's deadline for filing the final Interconnection Agreement conforming to the Commission's Order on Reconsideration entered October 7, 2003 in this matter. Currently, the deadline is November 6, 2003 (30 days from entry of the order). However, due to the complexity of some of the language relating to the issue involved in the Commission's Order on Reconsideration, the parties are in agreement that more time is needed to finalize the language.

Therefore, the parties jointly request that the Commission extend the deadline for filing the final Interconnection Agreement by 30 days, to December 8, 2003.
