Re: Joint Application of Commonwealth Telephone Company, CTSI, LLC and CTE Telecom, LLC d/b/a Commonwealth Long Distance Company For All Approvals Under the Public Utility Code for the Acquisition By Citizens Communication Company of All Stock of the Joint Applicants' Corporate Parent, Commonwealth Telephone Enterprises, Inc.; Docket Nos. A-310800F0010, A-311095F0005 and A-311225F0003

Petition For Emergency Order or, in the Alternative, Stay of Proceeding Pending Adjudication of the Broadband Cable Association of Pennsylvania's Party Status.

On January 26, 2007, the Broadband Cable Association of Pennsylvania (BCAP) filed a Petition for Emergency Order, or in the alternative, a stay of the proceeding in the above-captioned docket pending its party status in the proposed acquisition of Commonwealth Telephone Company by Citizens Communications Company. By Initial Decision issued on December 14, 2006, Administrative Law Judge Susan D. Colwell denied party status to BCAP in this proceeding. BCAP filed Exceptions to the Initial Decision on January 3, 2007. In addition, on January 19, 2007, the Joint Applicants and other Parties filed a Joint Petition for Settlement with a request that the Commission take action by March 1, 2007. A Recommended Decision on the Joint Petition for Settlement is expected to be issued soon.


In the Petition for Emergency Order, BCAP is requesting that the Commission direct the ALJ to refrain from considering a proposed settlement until the Commission has ruled on the pending Exceptions to the Initial Decision which denied BCAP party status. BCAP also requests that the Commission establish a schedule under which interested parties would file answers to its Petition for Emergency Order by February 1, 2007, and BCAP would reply on February 5, 2007, in time for the Commission to take action at the February 8, 2007 Public Meeting.

The Commission finds that the public interest is served by expedited consideration of this Petition. Accordingly, all interested parties are hereby directed to file Answers to BCAP's Petition no later than 12:00 Noon on February 5, 2007. No

replies will be accepted. All answers must be in electronic Word format and received by the Office of Special Assistants, cwalkerdav@state.pa.us, rmarinko@state.pa.us, msamuel@state.pa.us, aarnold@state.pa.us, and served on all Parties by the above-stated deadline. Additionally, hard copies of any answers should be filed with the Commission's Secretary by close of business on February 5, 2007.




