Pursuant to the provisions of its Alternative Regulation and Network Modernization Plan, approved by the Pennsylvania Public Utility Commission at Docket No. P-00961024, Frontier Communications Commonwealth Telephone Company ("Frontier Commonwealth") respectfully inform the Commission that on January 30, 2015, it will submit its annual Price Stability Index/Service Price Index filing. At this time, it is anticipated that the Frontier Commonwealth will not request any rate increases. Frontier Commonwealth intends to submit a filing which will permanently roll the State Tax Adjustment Surcharge into basic rates on a revenue neutral basis.
